December 18, 2017

The meeting was called to order by Tim Wittenbach at 7:00 pm.

Roll Call - J. Hoffman, Wittenbach, H. Hoffman, Gillett, Rasch, were present. None absent

Old Business:

 Hall Facility Update- Survey and Topography Study- Lowell Congregational Church building discussion

The Lincoln Lake township property has been surveyed and had a topography study completed by Roosien and Associates.

In mid-December, Supervisor Wittenbach was contacted by the pastor of Park Congregational Church to approach the Vergennes Township Board with information that the Lowell Congregational Church may be looking to sell their property. The Pastor asked if the Township Board would have any preliminary interest in the property. The board had a lengthy discussion of the building size and design, property layout, and the potential use as the future township hall. The board believes this site, at the right price, could be an option for the future township offices. J. Hoffman motioned to continue to gather information on the Lowell Congregational Church facility and pursue this building as an option for the future township hall. Wittenbach supported. The Board believes there are a lot of unknowns that need to be answered, but if this building becomes available, this could be a viable option for the township offices. It was discussed to inform Tim

Spitzley the architect on the current building project, involved and get his input on possible design renovations. All members voted yes. **Motion carried**.

New Business:

1. Appointments

- **Planning Commission** Wittenbach motioned to reappoint Penny Rozema to the Planning Commission- term ending 2020 and appoint Stephanie Peel to fill the vacant term –ending 2019. J. Hoffman seconded. All members voted yes. **Motion carried.**
- **Zoning Board of Appeals**-Wittenbach motioned to reappoint Roger Odell to another term on the Zoning Board of Appeals, Term ended 2020. Gillett seconded. All members voted yes. **Motion carried.**
- Construction Board of Appeals-Wittenbach motioned to reappoint Nate Post to another term on the Construction Board of Appeals- Gillett seconded. All members voted yes. **Motion carried.**
- Township Treasurer-The Board received two application and held interviews on for the Treasurer's appointment. The Board discussed the applicants and their qualifications. Wittenbach motioned to appoint Deputy Treasurer Janine Mork to the position of Township Treasurer as her qualifications best fit the need for the position. Gillett supported. Members Wittenbach, H. Hoffman, Gillett and Rasch voted yes. J. Hoffman did not have a vote in this position. Motion carried.

2. CDBG 2017-2018 Allocations

The Kent County Community Action Program manager Darrell Singleton II sent a letter with approval for the FY17-18 Community Development Block Grant funding for North Kent Transit of \$3879.00. Gillett Motioned for a Public Hearing to take place for approval of the allocations of these funds. Wittenbach seconded. All members voted yes. **Motion carried**.

3. Collection of Summer taxes for LAS, GRCC & KISD

J. Hoffman motioned to collect the summer taxes for Lowell Area Schools, Grand Rapids Community College and Kent Intermediate School District. Seconded by H. Hoffman. All members voted yes. **Motion carried.**
