## **MINUTES**

The meeting was called to order by Tim Wittenbach at 7:02 pm.

The March 4, 2019 Special Board Meeting minutes were approved with a change to the spelling of Trustee Rasch's name with a motion from Gillett, seconded by Mork. All members voted yes. **Motion carried.** 

The treasurer's report was read. Gillett motioned to pay the bills as presented, Rasch seconded. All members voted yes, **Motion carried.** 

## **Public Comment**

There was a question why there is environmental testing at the 69 Lincoln Lake property. It was explained that the township is in the process of purchasing this location for the site of the township hall and this is necessary testing to assure there are no known environmental issues at the property prior to purchase.

# **Old Business:**

1. Township Hall Building Update: - Tim Spitzley, architech is working on two ideas and will have these available before the April 15, 2019 meeting. The Environmental Study is moving forward with onsite inspections of the property. Roosien did the initial survey for the property and it looks like there is access to the 66' easement that is on the north side of the property. Doezema is researching this.

## **New Business:**

1. Budget Amendments for 2018-19 budget - in addition to the recommended Budget Amendments as attached-addition of 101-000-403 current tax collection change from \$176,500 to \$174,300. Motion to approve the attached budget

- amendments for 2018-2019 with the addition of the revenue current tax collection change by Wittenbach, seconded by Gillett. All voted yes- **Motion** Carried
- Cemetery Program Discussion- BS&A (BS& A CEMETERY PROGRAM) The Board discussed the pros and cons of purchasing the software. Motion made by Gillett to purchase the BS&A cemetery software program for \$5070 first year implementation, \$400 annual – after the first year- fee. Wittenbach seconded. All voted yes. Motion Carried.
- 3. Budget updates for 2019/2020- The Board had discussion on adding The Right Place membership. Gillette motioned to approve \$1500 for Vergennes Township to become a member of The Right Place they provide a much needed service for companies in Kent County and in Vergennes Township. Wittenbach seconded. This will be added to expense account 101-248-803-00 membership and dues-changing this line item from \$4,100 to \$5,600. All voted ves. Motion carried.
- 4. Adoption of 2019-20 Budget Gillette Motioned to adopt the 2019/2020 with the addition to account 101-248-803-00, Rasch seconded. A roll call vote was taken. Rasch –Yes, Wittenbach-Yes, Mork-Yes, Hoffman-Yes, Gillett-Yes. Noone voted no. **Motion Carried.**
- 5. Fire Commission Member Agreement Revision Action Request- Wittenbach will talk to Cal Brinks. Gillett Motioned to table to the April meeting to give time to gather more information. Hoffman seconded. All voted yes. **Motion Carried.**
- 6. Safe Deposit Box- Motion made by Mork to Close Huntington Bank Deposit Box, Gillett seconded. All voted Yes. **Motion Carried.**
- 7. Planning Commission a notice will be published seeking applicants for an open member position which was made vacant by the resignation of Penny Rosema.
- 8. New Zoning Forms- Gillett motioned to approve the three new zoning forms with the addition to the affidavit wording to include after. "I also certify and affirm that this application is "<u>for an agricultural use building</u>"... Hoffman seconded. All voted yes. **Motion carried.**
