Guest Speaker: Kent District Library

Katie Oliver, Board Member, Brian Mortimone, Human Resource Director for KDL and Heather Wood, Englehardt Library Branch Manager all were in attendance to share information about the services and programs KDL has provided over the last year. They shared about their increased availability of Wifi Hot Spots that have 25 gigs of data available to check out. They shared that Vergennes Township residents checked out 62,449 items in 2017.
