1. **New Township Hall Update progress -** Spitzley reported to Hoffman that construction drawings are on track. Hoffman and Spitzley will set date for special meeting.

## New Business -

 Salary Resolution 2020-02 – Motion by Gillett to accept the amended salary resolution 2020-02. Wittenbach seconded the motion. Salary Resolution 2020- Salary Resolution was adopted as follows: Supervisor salary from \$26085 to \$27400; Clerk's salary from \$26085 to \$27400; Treasurer's salary from \$26085 to \$27400. Assessor Salary remains at \$27050. Assessing Office Assistant remains at \$15.50 per hour. Zoning Administrator remain at \$15340; Planning Administrator remain at \$15340; Deputy Clerk remain at \$20.50 per hour; Deputy Treasurer raise to \$20.50 per hour; Reception/Building Department Administration from \$15.50 per hour raised to \$15.50 per hour; Trustee's Salary from \$3,000 to \$3,150 per year salary; Planning & Zoning Commission remain at \$100 per diem; Board of Review: March \$200; July \$50; Dec \$50; Org Mtg: \$25 - \$325 All Board members voted yes; None no- **Motion Carried** 

- 2. Fire Authority Discussion Wittenbach updated the board. Chairman and Vergennes Representative Jim Herb's resignation was discussed. Wittenbach provided an update on McGrath proposal, and the Board discussed the fire department's current runs, man hours and counts. Discussion on looking at cost per run and comparison of medical runs compared to non-medical runs. What contracts with other providers outside the Lowell Fire Department would be in comparison. County Truck is due in 2022. The county will pay \$204,000 towards a new vehicle and the Authority will budget for the remaining balance to be split equally amongst the three municipalities in the authority. The Lowell Area Fire Authority contract was discussed. The purposed budget has an increase in firefighter's wages- this was expected. No Capital purchases scheduled for 20-2021. The New County truck will be ordered in late 2020 to be delivered in 2022.
- 3. Board discussed the Zoning Ordinance and Williams & Works Memo
  - Temporary Dwelling Ordinance 201.415 (B) Wittenbach motioned to change to "administrative review". Gillette seconded the motion. All members voted yes. Motion carried.
  - Bed & Breadfasts in R-2 and R-3 districts and Ambiguous language in the R-3 District, specifically section 201.306 (c) (4) – Wittenbach motioned to accept the planning commission's recommendation. Gillette seconded the motion. All members voted yes. Motion carried.
