Minutes

The meeting was called to order by Tim Wittenbach at 7:00 p.m. Pledge followed.

Roll Call -Ford, Mork, Gillett, Wittenbach, Rasch present

Approval of the Agenda – Mork motioned to approve the agenda. Gillett supported. All members voted yes. **Motion carried.**

Unfinished Business –

1. **Fire Department Budget-** Gillett moved to accept the 2023-2024 Fire budget. Rasch supported. All members voted yes. **Motion carried.**

New Business -

- 1. SEU permit 300/320 Lincoln Lake Ave SE-Ryan Harrington is seeking to rent space to Berry's Diesel, which performs in house and mobile truck repairs. The two businesses, HFS Equipment Sales and Leasing and Berry's Diesel, would operate under one roof. Gillett motioned that the Special Exception Use be forwarded to the Planning Commission for their review. Mork seconded. All members voted yes. Motion carried.

- **ZBA** Wittenbach motioned to reappoint Pete Gustafson and Bill Makuski. Gillett supported.
- **BOR** Wittenbach motioned to reappoint Jim Herb, Ken Ford, and Steve Hanson. Gillett supported. Ford asked if Nick Dewey could be offered the alternate position for the BOR, as there is none. Wittenbach moved to allow Nick Dewey to be an alternate if it worked in his schedule. Gillett supported. All members voted yes to the appointments. **Motions carried.**
- 3. Lawn Care Proposals-Proposals from Blockhead Excavation and Landscaping, Maley's Lawn and Snow Works and Wabeke Lawn were reviewed. Gillette moved to table a decision until the January board meeting to allow for more research. Wittenbach seconded the motion. All members voted yes. Motion carried.
