### HISTORICAL

# *"As I First Saw It, Lowell in 1854 by N. B. Blain Written and printed in the Lowell Ledger on November 12, 1914*

My first appearance in Lowell occurred on April 18th, 1854. We had been living in Grand Rapids a few years, but R. D. Winegar and Orson Peck moved from there to Lowell the fall before and were so well please with its prospects that they induced my father to buy forty acres of land there.

We left Grand Rapids April 17 and got as far as the Wooster farm in Vergennes (more recently known as the

Merriman farm) at night; remained there overnight and in the morning as soon as we could get our procession in marching order, said procession being made up of two teams under the supervision of Sherman Wooster and William Parker, we resumed our march to Lowell. After turning south at Fox's Corners, we soon came in sight of the residence of Doctor Richards, which is still standing where it then did. From there the road wound around through the woods and brought us out to the bank of Flat River opposite the Indian settlement and a short distance south of the home of Lucas Robinson."

This article shows a difference in travel before the creation of M21 in 1928. Travel from Grand Rapids took a more direct route to the east, passing right through Vergennes Township. This route described above travels to the Wooster farm, also known as the Merriman farm in 1914. Plat maps show us that this is the farm on the NW corner of the Vergennes and Parnell intersection. From there they traveled to Fox's Corners, the intersection of Vergennes and Lincoln Lake Ave, and turned south. They soon came to the residence of Dr. Richards. He owned the NW quarter of section 35. This is the land where the J&H gas station is, the Fox's Corner and St. Mary's

cemeteries, the airport and land to the south. Though the house was standing in 1914 it no longer is today. From there they traveled to the bank of the Flat River, south of the Lucas Robinson home. This house would have been in the SW quarter of section 35.

The article continues and details the businesses in Lowell and includes fun details such as how exciting it was in 1854 to see the steamboat arrive at the Lowell landing and watching the Odawa dances in the village north of town, in Vergennes Township, across the river from Lucas Robinson. While Blain thought he was enlightening the people of 1914, since the letter was published in the newspaper, we still have this information today!

#### **VERGENNES CEMETERIES**

Spring is an important time in our cemeteries. The township maintains six cemeteries. The historic ones are Historic Bailey, Krum-Blanding, Fox's Corners, and Fallas. The two active cemeteries are Alton and Bailey. Work begins with cleaning and mowing. Then volunteers flood the cemeteries placing flags for the veterans buried here. The veterans and their loved ones here are incredibly blessed! The Alton Cemetery flags were placed by the Lowell American Heritage Girls MI1208,

sponsored, and hosted by St. Patrick's in Parnell. The historic Cemeteries and Bailey veteran flags were placed by Rob, Genevieve and Evie McDaniels and Michelle Kendall. Thank you to all these volunteers for the care, love, and appreciation these veterans receive! Burial Rights in Alton and Bailey are available for purchase at the clerk's office. Resident price is \$250.00. per grave. Each grave is allowed one full burial, one full and one cremains, or two cremains.



#### **ASSESSING DEPARTMENT - FIELD REVIEWS**

Hello Vergennes Township Residents.

My name is Cory Burns. I am the assessor for Vergennes Township. I will be conducting field reviews throughout the summer and fall months. Michigan Statute requires that all property be evaluated annually based on current market conditions. This evaluation requires inspections, which includes exterior verifications, measuring buildings and other structures on the property, taking current digital photos, verifying the buildings current physical conditions, and reviewing the amenities present, and interviewing the property owners to determine bedrooms, baths, and type of basement, etc.

The State of Michigan has stated that 20% of the properties in a governmental unit be visited each year to review assessment record accuracy and to ensure that properties are being appraised and assessed at 50% of the market value. In efforts to continue our excellent standards, the Assessor's office strives to enhance the

annual review process and meet the State of Michigan's expectations. The goal is that the Assessing office will review at least 20% a year of the Township, then every single property is visited at least once every 5 years.

I will have a picture ID, as well as business cards (upon request). If you are not home during the inspection, I will leave a paper hanger notifying you that I was on your property. this newsletter.



### PLANNING AND ZONING

It has been a busy first half of the year for the Planning Commission in Vergennes Township. Industrial parcels on OE Bieri are quickly filling up as the township has approved facilities for contractor suites, an excavating company, and an electric company. A lot of building is happening there and only a few parcels remain undeveloped. The township also recently approved Harvest Meadows Phase 4, which is the final build out of the residential development off Alden Nash. Other interesting topics that have come before the Planning Commission include gravel operations, two private roads, and some additional facilities at a church.

Vergennes Township also has a home-based business ordinance, and the Township has received several inquiries over the past few months. While the ordinance is flexible, all home based business need to be registered, and generally should be conducted entirely indoors and not create much traffic or nuisance activity. Speaking of nuisance, there has also been an increase in complaints about junk and abandoned vehicles around the Township. The junk control ordinance is enforced, and citations may be issued for noncompliant properties. Please remember to finish up your spring cleaning.
